What can journalist Synkov, sharing information with the president of the country, do?

The bears are in an uncontrollable situation from the management of the state, the city / town on the properties with the effects of attacking the residents of the properties, followed by signaling through a siren or alarm about the danger by knocking on a metal object, the gate.

If someone else warns, and you are in a car, then calmly make a U-turn and leave this place.

(a situation that took place on June 3, 2023) where the owner of property 48 Brentwood Dr. in Avon, CT was the organizer.

The pleasure effect did not take place to see the bear attack the car. In that place, a calm turn and at the end of the turn a strong blow to the car - a broken break-light on the passenger side.

A few hours later, when returning to property at 24 Brentwood Dr, the situation is similar to that developed by the residents of property 48 Brentwood Dr earlier: a re-try to drive to the property at 24 Brentwood Dr., which we own, had the same effect of warning not to go there.

Running bodies waving their arms was a warning to turn around, which was done by the driver/journalist Nikolay Synkov sharing information with the president of the country.

A few hours later, having received consent for an escort from the police along the chain - a representative of the FBI (call) a representative of the police (call from the FBI) with a police officer's statement that an escort would be provided to the house from property 48 Brentwood Dr. to property 24 Brentwood Dr. At the entrance to property 48 Brentwood Dr., the escort announced itself by flashing the police cars completely blocked the passage in any direction along the street Brentwood Dr. There was an effect - a police escort to the station of the Avon Police Department: "safe escort" of the driver of the car took place with the effects of treatment - see the conclusion of the doctors (Appendix 1).

After a n-th number of minutes over an hour and the execution by the journalist Synkov of all the regulations and methodological forms of actions without any understanding of what they were asking for (it was shown with gestures what was needed - there was no interpreter, to provide the necessary assistance, the diabetes of the journalist Synkov in the name of Synkov was called a local ambulance help; what ambulance representatives did, there was no explanation for their methods, reading, through gestures it became clear. There was no interpreter. The conversations of the policemen 3-4-5 reached the quantitative composition amicably and cheerfully discussed what? unknown

At the end, two police officers initiated fingerprints and a photo.

After that, they rewrote the warning sheets issued a little earlier and handed them over again.

Then they offered to take away all the things taken out of the pockets by the policemen and put on the table, among which there were journalistic badges - see pictures above. Putting everything in his bosom (there is no toilet, no washbasin), without laying it out in the same places, the policeman led him to the front door where journalist Tatyana Ishutkina was also sitting - see the Appendix 2 with her journalist badge and a business card) with which both journalists subsequently went to their property at 24 Brentwood Dr. and, without any obstacles from the residents of property 48 Brentwood Dr., who had done preventive punitive actions a little earlier, drive to property 24 Brentwood Dr. bypassing property 48 Brentwood Dr. to 24 Brentwood Dr, where the office of journalists is located.

The next day, passing by property 48 Brentwood Dr. in both directions, photographs were taken by journalist Ishutkina who territorially paid attention to the back section of the property, a bear trail was supposed. Is there a bear rookery there?

The next day there were re-shoots with the effects of the search for a bear trail and the presence of a bear, broken sections of a tree and any buildings.

This is a real description of the events that took place on June 3, 2023, since the passage through the property area past property 48 Brentwood Dr. is blocked by the police and can be repeated at any time with seizure actions far from discussion, there is no interpreter, no doctor.

Conclusion. Any discussions, summons to any court of journalist Nikolay Synkov could not be appropriate since the journalist was doing his job collecting information about the situation of the bear-residents of the Avon properties with the effects of significant unquestioning security for any actors residents of the house 48 Brentwood Dr. by the police and so the same for his own life.

The material and moral damage (see Appendix 3) inflicted on the journalist Nikolay Synkov initiating information for the president of the country with the effect of "sharing" (see letter from President Biden in the Appendix 4) by the police officers is determined as following:
